- Enter a carbon price trajectory in 2020 (€ 56 / tCO<sub>2</sub>e). All economic operators need visibility. Let me be clear. It is a smart way to finance the energy transition and the fight against insecurity (control of energy).-----
- Ensure that all sectors, including road transport, carry this energy climate contribution.-----
- Reduce the tax benefit 2 cents (15 cents in total) of diesel in 2016, while strengthening using the vehicle for change for modest households.-----
- Increase the budget for official development assistance in accordance with the announcement of the President of the French Republic.-----How far can France being credible, if not only the speeches and commitments ahead of the COP 21 ?"/ Official Statement Foundation Nicolas Hulot. (Nicolas Hulot is special Envoy of the french President Hollande for the climate change and COP21 emissary)
